The President just recently released the Administration's Fiscal Year 2022 Budget Request, prioritizing:

- · Partnerships with rural communities to grow their economies and tackle poverty
- Creation of jobs to improve water infrastructure
- Investments in technology to increase drought resilience among agricultural producers
- Support for agriculture resource management and improve irrigation for Tribes and insular areas
- Increase in adoption of net-zero agricultural technologies
- Investments in affordable housing in Tribal communities
- Funds for Tribal-specific climate change mitigation efforts
- Creation of a racial equity commission to address longstanding discrimination across the USDA
- \$5 billion towards debt relief for socially disadvantaged farmers
- \$2.9 million for the Office of Tribal Relations within the Office of the Secretary of Agriculture

The overall requested <u>USDA-specific budget for FY 2022</u> is \$198.1 billion. The items of most interest to the Intertribal Agriculture Council and its members include:
